Linklaters quit as Barclays adviser over 'unlawful' loan fears

Magic circle firm Linklaters pulled out of advising Barclays on a controversial loan to Qatar at the height of the financial crisis, it has been claimed.

Documents filed at the High Court in a civil suit allege that Linklaters quit advising the bank because it was concerned that a £3 billion loan made to Qatar through the gulf state's Ministry of Economy and Finance in 2008 was not lawful. The documents were filed by investment firm PCP Capital Partners, which is suing Barclays over claims that the bank paid undisclosed fees to secure funding.

During the 2008 financial crisis Barclays raised billions of pounds from Qatari investors to stay afloat. However, it is alleged that part of this funding came from money Barclays had already given to the state.

PCP, in a case filed last year, alleged that Barclays lent Qatar £3bn, which was then pumped back into the bank as part of the rescue deal.

According to the *Financial Times*, documents filed this month show that Linklaters stopped advising the bank a day after urging the bank that the loan documents included a caveat stressing that the money would not be reinvested in the bank. The firm, the paper reports, was concerned that the loan would involve 'unlawful financial assistance by Barclays for the purchase of its own shares'.

The documents cite an email between two Barclays executives who said Linklaters had 'resigned' on conflict grounds and on concerns about 'where cash ends up'. The email continues: 'It should be inferred from this that i) Linklaters resigned (at least in part) because it was concerned that the Qatar loan would be illegal.'

In June this year Barclays was charged by the Serious Fraud Office over both the £3bn loan and capital-raising arrangements with sovereign wealth fund Qatar Holding LLC and Challenger Universal Ltd.

Former Barclays chief executive John Varley is among the charged, along with former senior executives Roger Jenkins, Thomas Kalaris and Richard Boath.

Barclays plc, Varley, Jenkins, Kalaris and Boath have been charged with conspiracy to commit fraud by false representation. In addition, Barclays, Varley and Jenkins have been charged with conspiracy to commit fraud by false representation in relation to capital raising as well as with unlawful financial assistance.

The defendants in the criminal action, including the bank, have not formally entered a plea. Varley and Jenkins have indicated they will plead not guilty.

Dear Mr Mann & Mr Garnier,

I have to ask you some very serious questions regarding Jes Staley, CEO of Barclays. Mr Staley threatened me with legal action, which I believe he can only win by use of clandestine political influence.

The Daily Mail in October 2015, in an article by Hugu Duncan, claimed that Staley had i) been lobbied for the role as CEO by Jeffrey Epstein and ii) that Staley's appointment would face scrutiny from the Treasury Select Committee. The article is linked here:

Now I issue a FOIA request against Parliament to find a transcript of the session in which Staley would face scrutiny. The respondent denied that such a session took place.

Before I jump to the obvious conclusion - I notice that your two names, John Mann and Mark Garnier are explicitly stated in the Daily Mail article.

Can you two please confirm whether the FOIA response is pertinent? Was there any grilling of Staley for his connections to Jeffrey Epstein. I am sure I do not have to remind you of Epstein's Black Book, or his arrest and prosecution for child trafficking/solicitation.

It should be a serious matter if the DM was misled into believing an interview would take place, but Staley get away unchallenged.

But it gets worse....

Recently Gail A Evans (aka Katherine Frisk), a South African citizen, appears to have gone missing . She writes for a number of newspapers including Veterans Today and the International Reporter (theinternationalreporter.org), for which she is the sole editor. As you can see from the latter, her last publication was 9th July, some 3 weeks ago. Gail's article on that page exposed Staley's Epstein connections by resurrecting the DM article and adding a few inferences based on the conduct of the SFO in the Qatar fraud case against Barclays. I fear Gail and I got a bit too close to the truth and that Staley may be behind her disappearance. South Africa though, has to be admitted, can be a dangerous place.

Whatever the truth about Gail, the courts should be informed that one my defendants' CEOs (Barclays) appears to have won his job as a result of profoundly corrupt lobbying from a child trafficker, and that due scrutiny of his appointment was not undertaken - and most seriously faked - unless one of you two can show otherwise.

Some months ago I sent the entire Treasury Committee proof that the SFO and the FCA allowed Deutsche Bank to rig its audits. My document provided electronic signatures to verify that the two agencies had enough info to challenge DB. Now that DB appears to have incriminated Barclays, you can see how these connections need to be brought to the attention of the House.

If there is no probative answer to this email I think anyone is entirely reasonable to assert that no scrutiny of Staley took place - based on the FOIA response and the failure of sources to contest otherwise.

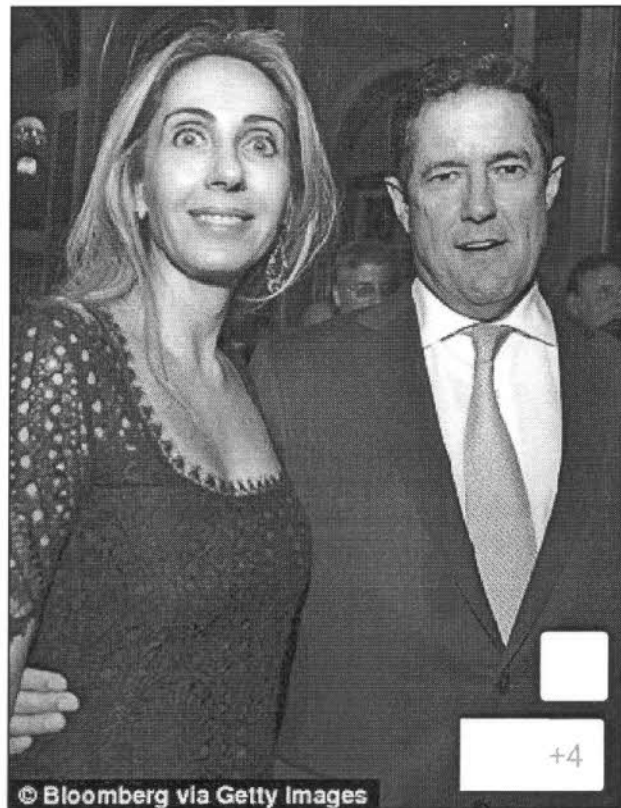

The new boss of Barclays faces a grilling from MPs over his links to a notorious paedophile friend of Prince Andrew.

Jes Staley, a hedge fund manager and former high-flyer at Wall Street giant JPMorgan, is understood to have been chosen as the man to replace ousted Barclays chief executive Antony Jenkins.

But yesterday it emerged that the American was secretly backed for the job in 2012 by convicted sex offender Jeffery Epstein – a friend of the Duke of York who was sentenced to more than a year behind bars in 2008.

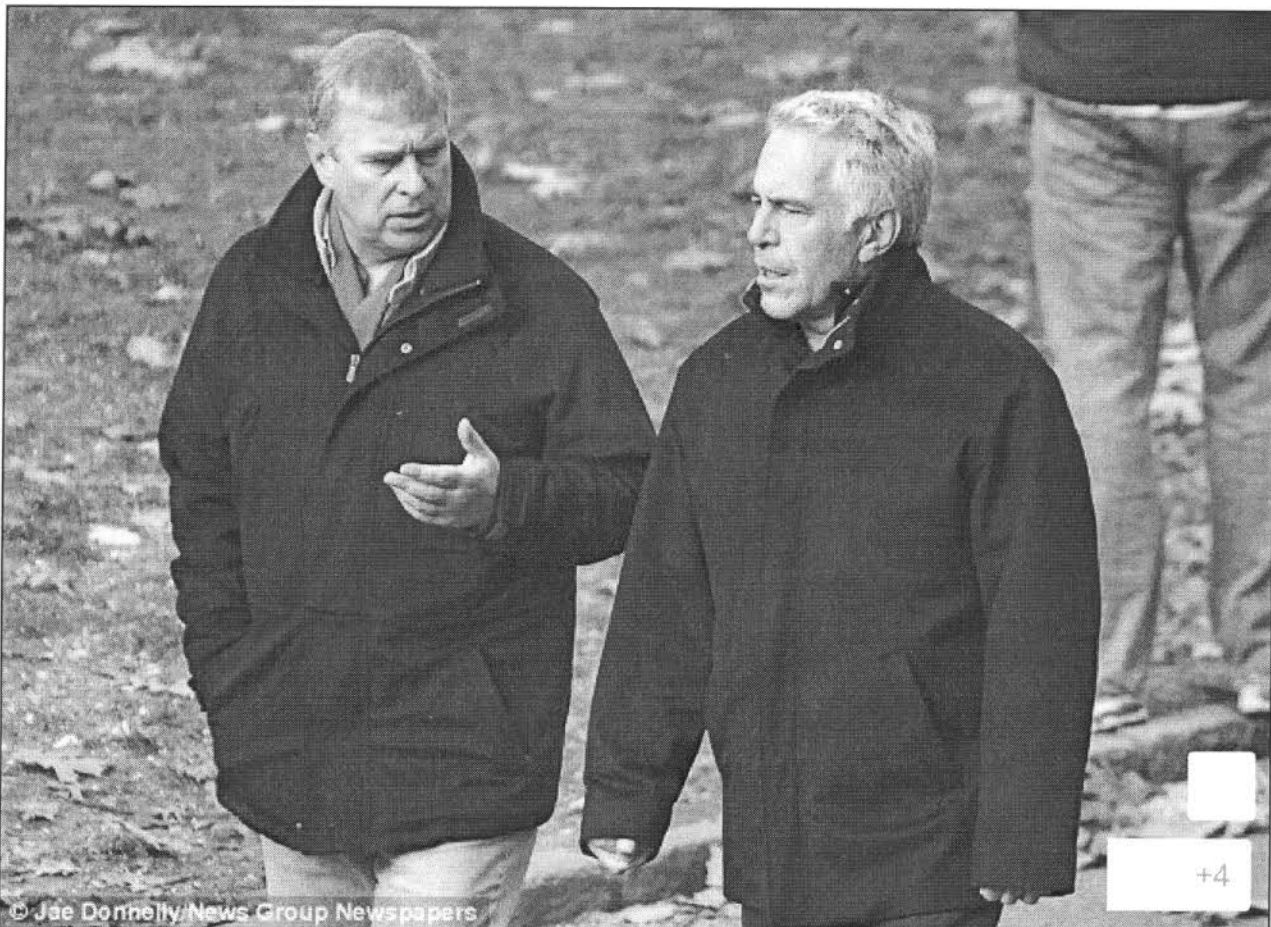

Mr Staley denies ever asking Mr Epstein act as his cheerleader for any job and Barclays also said its board was not lobbied by Mr Epstein.

It is thought Mr Epstein was acting on his own initiative.

But one member of the Treasury Select Committee said MPs will want 'clear answers' from Mr Staley over his links with Mr Epstein.

Another said 'it is the sort of thing' that MPs will want to know about if Mr Staley is confirmed as the new Barclays boss.

Barclays has yet to officially announce that Mr Staley has got the job but the appointment is an open secret in the City.

The **Mail on Sunday** claimed that Mr Epstein – who was convicted in 2008 after paying a teenage girl for sex – began pushing Mr Staley forward for the Barclays job in 2012.

The pair are said to have met in Mr Epstein's plush New York home that year.

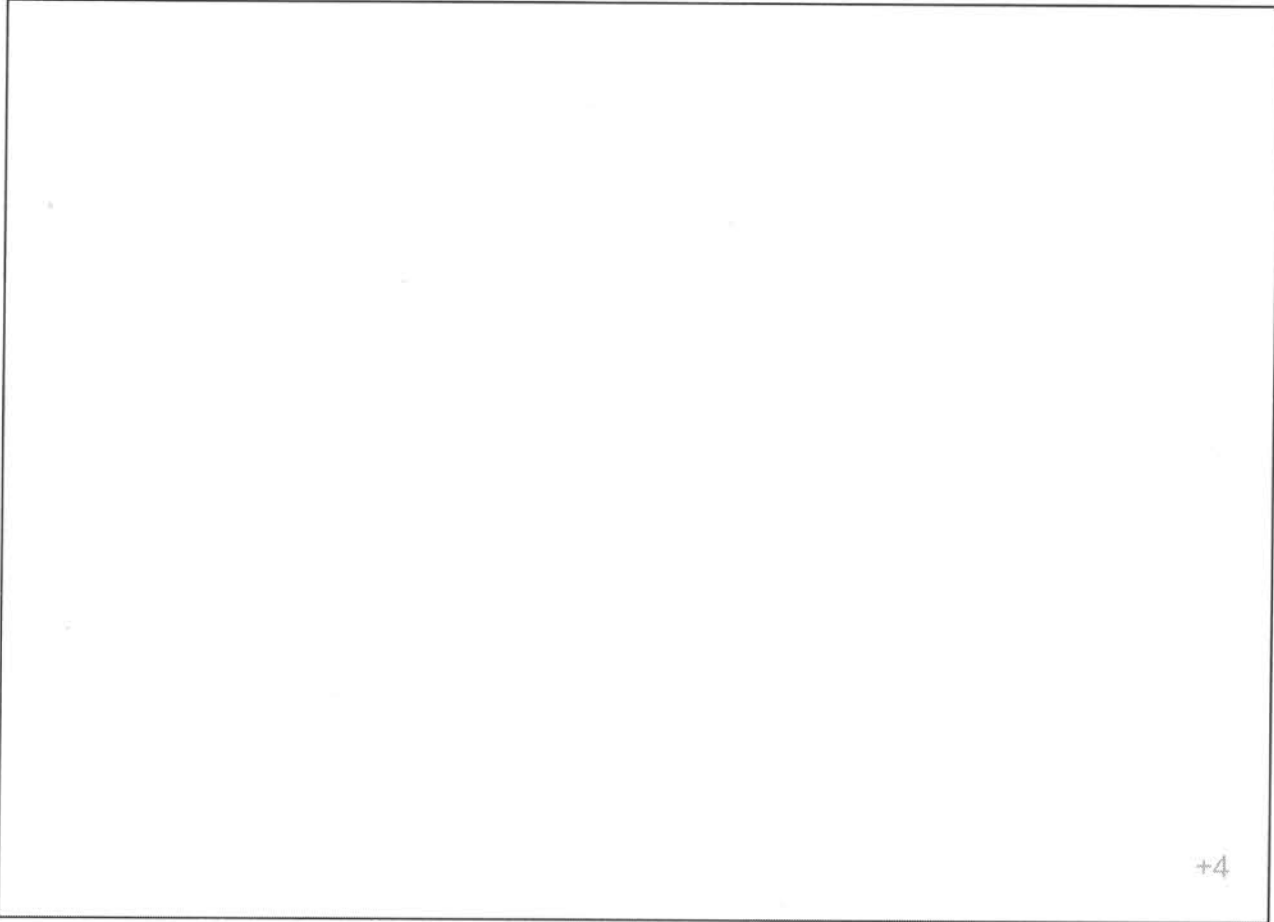

It was also claimed that George Osborne was blocking Mr Staley's move to Barclays in 2012 and Mr Epstein wanted the get the Chancellor to change his mind.

The Treasury and Bank of England were said to be uncomfortable with another 'casino' banker taking the reins at Barclays following the departure of Mr Diamond.

But Mr Staley looks set to be named chief executive this time around following gruelling interviews with top UK regulators.

Former Barclays chairman Sir David Walker – who was also seen as an obstacle to Mr Staley getting the job in 2012 – has left.

MPs on the Treasury Select Committee have already said they plan to haul Mr Staley before them amid worries the appointment may herald a return to the aggressive culture and focus on investment banking fostered by Mr Diamond.

Last night they said they would also quiz Mr Staley about Mr Epstein.

Labour MP John Mann, a member of the committee, said: 'I'm sure the committee will want him in front of it. I'm sure he would be asked about it. It requires some clear answers.'

Tory MP Mark Garnier, who also sits on the committee, said 'it is the sort of thing' MPs will pick up on when Mr Staley appears before them.

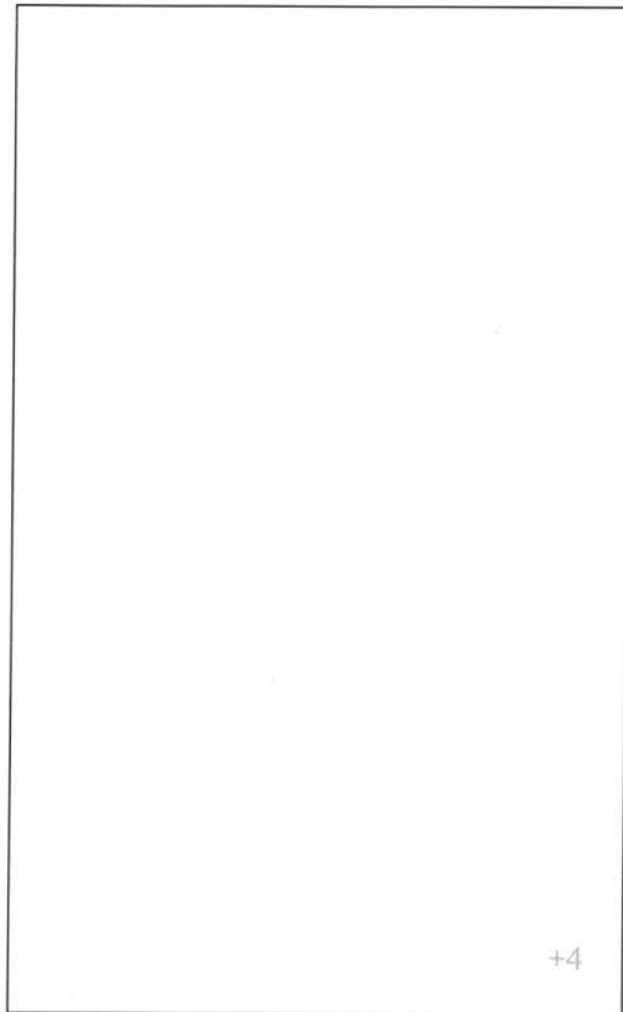
He said MPs will want to know if Mr Staley is 'the right man for the job' and added that 'a small part of that is the company he keeps'.

But Mr Garnier said of greater concern were his plans for the bank.

'You are going back to an investment banker and a hedge fund manager,' he said. 'What does he know about the individuals on the street and the retail customers? That is one of the big question we would want to ask.'

A spokesman for Mr Staley said: 'At no time has Mr Staley asked Mr Epstein to make representations on his behalf regarding any role.'

A Barclays spokesman said: 'Barclays categorically denies it has received any approach from Mr Epstein regarding any candidate for the vacant [chief executive] role.'

Barclays customers were left unable to get money from cash machines and pay with debit cards following a systems failure on Saturday.

The problems were due to a maintenance glitch in its systems ahead of the clocks going back on Sunday morning.

Customers were effectively locked out of their accounts from Saturday into Sunday, with the number of worried calls made leaving the bank's call centres unable to cope.

Barclays said the problem was an internal one and was not caused by hackers.

The head of the British Bankers' Association has previously said banks' computer systems are creaking under the strain of customers moving to online and mobile banking. Barclays said the problem had now been fixed.

Barclays boss Staley feels shareholder ire over whistleblower

LONDON (Reuters) - Barclays Chief Executive Jes Staley faced calls from individual shareholders to resign and received lukewarm backing in a vote to reappoint him at the bank's annual general meeting, following his attempts to unmask a whistleblower.

The British bank said last month it had reprimanded Staley and would cut his bonus after he twice attempted to identify the author of a letter that revealed “concerns of a personal nature” about an unnamed senior employee.

Staley faced much higher than usual abstentions at the Barclays annual general meeting on Wednesday, with only 62 percent of possible votes cast. This compared with more than 70 percent for the lender’s other board members in a sign of investor concerns after ISS, a shareholder proxy firm, last month advised them to abstain on Staley’s board re-election.

However, of those votes that were cast rather than withheld, 97 percent were in favor of Staley’s reappointment and he got a public endorsement from Chairman John McFarlane, who said that he was standing by the chief executive.

“You know me, if I thought he should go he would have gone,” McFarlane told investors.

Shareholders questioned how Staley could not have been aware of the lender’s policies prohibiting such attempts to unmask whistleblowers, and said his actions brought shame on the bank.

“Will you act now with integrity and honor and resign,” shareholder Michael Mason-Mahon, a frequent activist at major British banks’ annual general meetings, asked Staley at Barclays’ own AGM in London’s Royal Festival Hall.

“I made a mistake in becoming involved in an issue which I should have left to the business to deal with,” Staley said.

McFarlane said Staley made a mistake but not one that should cost him his career.

“The action of going through a red light is not that you lose your license,” McFarlane said.

McFarlane told reporters after the meeting that Staley had the backing of the bank’s entire board, after they discussed how to handle his attempts to find out who was sending the

letters criticizing a Barclays executive.

Staley also did nothing wrong in relation to a dispute with private equity firm KKR & Co (KKR.N) and Staley's brother-in-law, McFarlane said.

That dispute, another headache for the Barclays CEO, revolves around Staley's actions on behalf of his brother-in-law Jorge Nitzan after a deal between him and the buyout firm went sour.

Staley told the AGM that he did not see a need for Barclays to shift jobs or significant operations out of Britain as a result of the country's vote last June to leave the European Union, regardless of how the exit negotiations pan out.

Barclays shares were 2 percent higher by 1452 GMT (10.52 a.m. ET), the third best performer in the STOXX Europe 600 banks index .SX7P.

The Clinton-Silsby Trafficking Scandal And How The Media Attempted To Ignore/Cover It Up

Contrary to reports in the media, the crowd sourced investigation labeled by some as "Pizzagate" did not begin with internet sleuths digging through the Wikileaks Podesta Files releases looking for pizza parlors and encoded language discussing human trafficking. It began with the shocking discovery that Hillary and Bill Clinton provided assistance to convicted child trafficker, Laura Silsby, resulting in a reduced sentence for child trafficking.

Silsby was arrested at the Haitian border attempting to smuggle 33 children out of Haiti without documentation. Her sentence and charges were reduced after an intervention by Bill Clinton. In the aftermath of Silsby's arrest, her originally retained lawyer Jorge Puello was arrested in connection with an international smuggling ring accused of trafficking women and minors from Central America and Haiti. The revelation of this news in November was either ignored by the Western media or attacked by Clinton controlled publications.

I. Hillary Clinton Intervened Politically on Behalf of Laura Silsby

Laura Silsby is the former director of [The New Life Children's Refuge](#). Emails from her organization can be found in [Wikileaks' Hillary Clinton Email Archive](#) discussing the NGO before her arrest. Silsby's organization also appears in [Clinton's emails](#), soliciting donations for their "ministry." The Refuge was founded by Silsby and Charisa Coulter, both attendees of the Central Valley Baptist Church in Meridian, Idaho. Silsby was [reported](#) to have a history of bad debts and unpaid wages.

Laura had claimed she planned to build an orphanage in the Dominican Republic, but a [State Department diplomatic cable](#) revealed that authorities in the country said she never submitted an application for this purpose. They instead located to Haiti.

On January 29, 2010, Silsby was arrested with nine other American nationals attempting to steal 33 children from the country, most of whom were not even orphans and had families according to some [reports](#). [CNN](#) reported on February 9, 2010 that this was not the first time Silsby had attempted to traffic children out of Haiti. Haitian police acting on a tip had intercepted Silsby in an earlier, separate attempt to remove 40 children out of the country. She was turned back at the Haitian border. For a brief period, Haitian authorities were considering adding a [new kidnapping charge](#) based on this evidence.

Hillary and Bill Clinton took an extraordinary interest in Silsby's case from the moment she was arrested and almost immediately stepped in on her behalf. The [Harvard Human Rights Journal](#) stated that one of Bill Clinton's first acts as special envoy for the United Nations in Haiti "was to put out the fire of a child abduction scandal involving American citizens." On February 7th, 2010, [The Sunday Times](#) reported that Bill Clinton had intervened to strike a deal with the Haitian government, securing the release of all co-conspirators except for Silsby. [Prosecutors](#) ultimately sought a six-month sentence in Silsby's case, reducing charges for conspiracy and child abduction to mere "arranging irregular travel." A shockingly light penalty given the circumstances of her arrest, which would likely not have been possible but for the intervention of the Clintons in Silsby's case.

On February 9th, 2010 Hillary Clinton consulted with Counselor Cheryl Mills and other attorneys in an [email](#) discussing the U.S. Government's "options" regarding the arrested Americans. The [heavily redacted memo](#) attached to that email does not reveal what these "options" consisted of. However, the [State Department's American Citizens Services](#) is only authorized to offer lists of local, English speaking attorneys to Americans arrested or detained abroad. To go beyond that authorization is a severe violation of protocol and is illegal. [Additional emails](#) reveal that the State Department was involved with making statements on the Silsby scandal and preparing to assist Silsby's co-conspirators with their return to the United States, although this is consistent with State Department protocol in these situations.

II. Silsby's Lawyer and His Wife Were Both Arrested For Involvement in Human Sex Trafficking of Minors and Women

On February 11th, the [New York Times](#) reported that Silsby's original lawyer, Jorge Puello, was suspected of leading an international human trafficking ring involving women and minors. According to the [Harvard Human Rights Journal](#) Puello was ultimately [arrested](#) in an investigation being lead by U.S. Immigration and Customs Enforcement (ICE) and Homeland Security Investigations (HSI) in connection with the ring. He was wanted in the United States, El Salvador and Costa Rica for his involvement with a network trafficking Central Americans and Haitians.

At the time of his arrest, his wife was already imprisoned in El Salvador and "faced charges of presumed sexual exploitation of minors and women." Puello was ultimately [sentenced](#) to three years in federal prison for "alien smuggling." Another surprisingly light sentence given the original charges he was sought for. It is not known at this time whether or not Laura Silsby was associated with Puello's criminal enterprise.

III. The Daily Beast Engaged in an Illicit Cover Up Operation of the Above Information

On November 3rd, 2016, this author made a [post to Reddit](#) containing preliminary research and information on the above story. The post was made to the pro-Trump subreddit [r/the_donald](#) due to the forum's reputation as the only outlet on Reddit where news was not being censored during the U.S. Presidential Election. The same day, [Wikileaks](#) tweeted a link to the Reddit post labeling it as a "significant, if partisan, find."

On November 4th, 2016 [The Daily Beast](#) wrote a non-factual and intentionally misleading article covering the Clinton-Silsby scandal. They accused Wikileaks of publicizing a "Reddit conspiracy theory" which was "riddled with incorrect information." The author, [Ben Collins](#) neglected to do basic research on the totality of the links presented in the post as evidence. Mr. Collins attacked the policies of [r/the_donald](#) towards freedom of speech and accused the forum of being racist without citing extensive or definitive proof. At no point did [The Daily Beast](#) provide proof that the allegations were not true, and did not disprove any of the evidence submitted. A link to an extensive study of the case by the [Harvard Human Rights Journal](#) which clearly linked Bill Clinton to the scandal was totally ignored. They similarly failed to acknowledge or address emails published by Wikileaks between Hillary Clinton and her legal counsel which may potentially indicate that she violated State Department policy for the treatment of U.S.

for oversight and direction of The Daily Beast raises questions about the publication's journalistic independence and their commitment to factual and ethical reporting on current events and topics of public interest. Given their slanderous and incorrect reporting on the Clinton-Silsby scandal, it seems clear that they do not hold these values in high regard.

Since her release from detention in Haiti, Laura Silsby has returned to Idaho. In 2015, she married and took the last name Gayler. Silsby is currently employed by software company AlertSense as their Vice President of Marketing. AlertSense works with the Federal Government on FEMA's Integrated Public Alert & Warning System (IPAWS). One of IPAWS functions is to issue Amber Alerts during kidnapping events.

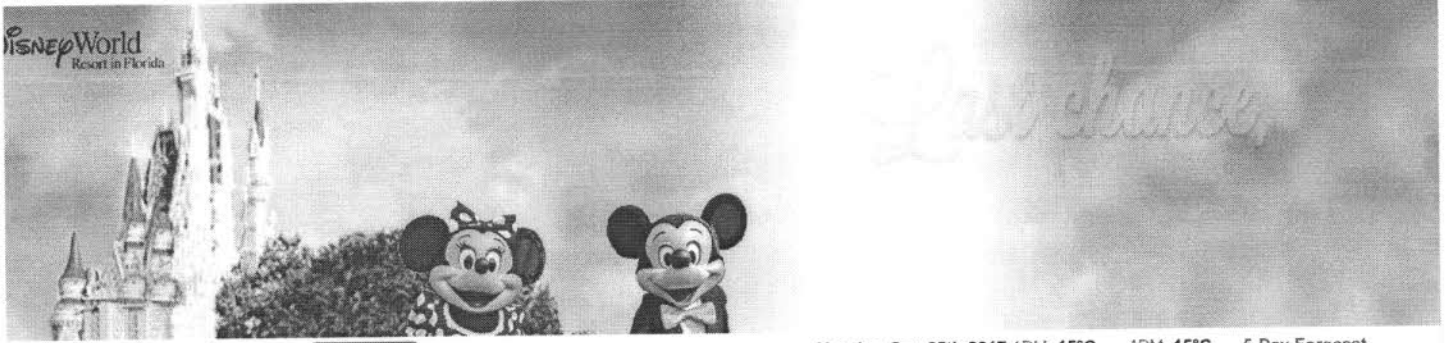

One third of Haiti orphans 'kidnapped' by American church group still have parents

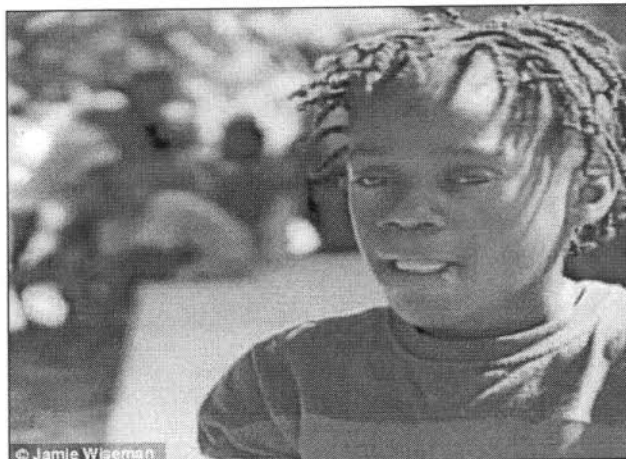

At least ten of the 33 children that an American church group tried to smuggle out of Haiti as orphans still have parents, it was revealed today.

One eight-year-old girl told aid workers that she thought her mother had arranged a short holiday for her and sobbed: 'I am not an orphan. I still have my parents.'

The disturbing development emerged as ten U.S. Baptists were set to appear in court in Port-au-Prince accused of trying to take the children out of the earthquake-ravaged country without any proper documentation.

The would-be orphans were being cared for last night at the SOS Children's Village in Santo on the outskirts of the Haitian capital, where they were taken at the weekend, hungry and dehydrated.

'Today they are much better but still some of them are very, very sad because they're waiting to be reunited with their parents,' said George Willeit, a member of the charity's emergency team.

Mr Willeit said at least ten of the children said they were not orphans. One of the smallest, just two or three months old, was so dehydrated she had to be taken to hospital.

'One girl thought she was going to a summer camp or a boarding school or something like that,' he added.

Child welfare groups also expressed outrage last night over the failed attempt to move the children to a hotel in the neighbouring Dominican Republic, where the group planned to build an orphanage.

The aim of the Baptists was to eventually arrange adoptions for all the children with American parents.

Haitian Prime Minister Max Bellerive also spoke out denouncing the group's 'illegal trafficking of children'.

But the Americans, five women and five men from an Idaho church, claim they went to Haiti with good intentions.

Spokeswoman Laura Silsby conceded that amidst the chaos, she had not obtained the necessary documents to cross the border with the children, who were aged between two months and twelve-years-old.

She claimed she intended to return to complete the paperwork once the children were settled in their new home.

The Baptists' 'Haitian Orphan Rescue Mission' was described as an effort to save abandoned, traumatised children.

Bill Clinton urges solution to Haiti 'kidnap' case

Case has distracted attention from quake relief efforts

PORT-AU-PRINCE, Feb 5 (Reuters) - Former U.S. President Bill Clinton urged the U.S. and Haitian governments on Friday to resolve the case of 10 American missionaries accused of trying to take children illegally out of quake-hit Haiti.

Clinton, named by the United Nations to coordinate relief efforts for survivors of the devastating Jan. 12 quake, made the appeal during a visit to the shattered Haitian capital, Port-au-Prince, his second since last month's disaster.

The accused U.S. missionaries, most of whom belong to an Idaho-based Baptist church, were arrested a week ago and charged on Thursday with child kidnapping and criminal association.

Haitian authorities say the group tried to take a busload of 33 Haitian children across the border into the Dominican Republic without any papers proving the minors were orphans or any official permission to take them out of the country.

The missionaries deny any intentional wrongdoing and say they were only trying to help children left destitute by the Jan. 12 earthquake, which killed more than 200,000 people, injured some 300,000 and left over a million more homeless.

The Americans' case is diplomatically sensitive and aid groups complain it has distracted media and world attention away from the struggle to feed and shelter hundreds of thousands of Haitians camped out in wrecked streets.

"What's important now is for the government of Haiti and the government of the United States to get together and work through this," Clinton told CNN in Port-au-Prince.

He said he understood the Haitian government's efforts to try to protect its children from possible child traffickers and unlawful adoptions following the catastrophic quake.

But he also said the missionaries could be telling the truth when they argued they simply wanted to help the children and did not mean to violate any laws. Evidence has emerged

"The government of Haiti ... (is) not looking for some big fight here. They just want to protect their children and they also want to make sure they have a good inventory so they don't send children away that maybe have an aunt or an uncle that have an income," Clinton said.

"I think they'll find a way to defuse the crisis and work through this," he added, but he said the case was not his direct responsibility.

The missionaries, five men and five women, were questioned individually on Friday by investigating judge Bernard Sainvil at the offices of the prosecutor in the city.

Officials said the judge would continue his investigation next Monday and Tuesday, before making a decision on whether to release the 10 or proceed with the case against them.

WASHINGTON MONITORING, NOT INTERFERING

The missionaries' lawyer, Edwin Coq, said he had requested the 10 be released provisionally pending the further hearings, but no decision was immediately taken on that.

Coq said the Americans, who had been held at police headquarters up to now, were taken after the questioning on Friday to established prisons -- the women to a women's prison in the Petionville suburb and the men to the quake-damaged central prison in the capital.

The U.S. government, which is spearheading the big relief operation in Haiti, has said it is providing the Americans with consular access and monitoring their case, but it has made clear it does not want to interfere.

"Obviously this is a matter for the Haitian judicial system," Secretary of State Hillary Clinton, who is Bill Clinton's wife, told reporters in Washington.

Haitian President Rene Preval's crippled administration, which has been accused by many of its citizens of failing to do enough to help quake survivors, has defended its decision to detain and charge the Americans.

"It is true the country has been brought to its knees by the earthquake, but we still have

The detained Americans were still hoping on Friday they would eventually be released. "We pray to God for the outcome," said the group's leader, Laura Silsby.

Another member of the group, which called itself the New Life Children's Refuge and planned to build an orphanage in the Dominican Republic for the Haitian children, said it was "unfortunate" that world attention was focusing on their case and not the plight of Haiti's earthquake victims.

"I think the most important thing is to continue to put the focus on the people, the kids who are suffering, because they need help. That's the reason why we were here in the first place, to help," Silas Daniel Thompson, 19, told Reuters while he was being taken to see the investigating judge.

Haiti's government has tightened adoption procedures since the quake, saying it feared unscrupulous traffickers could try to take advantage of the disaster by spiriting away vulnerable children. Officials said they already had reports of trafficking of minors, and even of human organs. According to a story published by Charisma news, it was a blogger on social media who first discovered the connection between Hillary Clinton and child trafficker Laura Silsby.

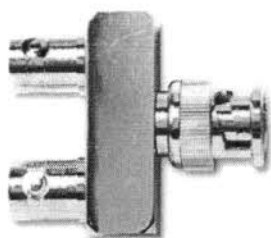

The discovery also included Wikileaks emails from Hillary Clinton, the content of which reveal Clinton contacting a lawyer regarding ten people arrested involved in the child trafficking ring. It was also revealed that the lawyer who represented Silsby was a convicted child sex trafficker.

The individual in question is one Laura Silsby, former director of The New Life Children's Refuge. She was caught trying to steal 33 children from the country, most of whom were not even orphans and families.

Hillary has a LONG history of interest in Ms. Silsby. Wikileak emails dating back till at least 2001 have been found in her archives discussing Laura's NGO. Laura had claimed she planned to build an orphanage in the Dominican Republic, but authorities in the country said she never submitted an application for this purpose. They instead located to Haiti.

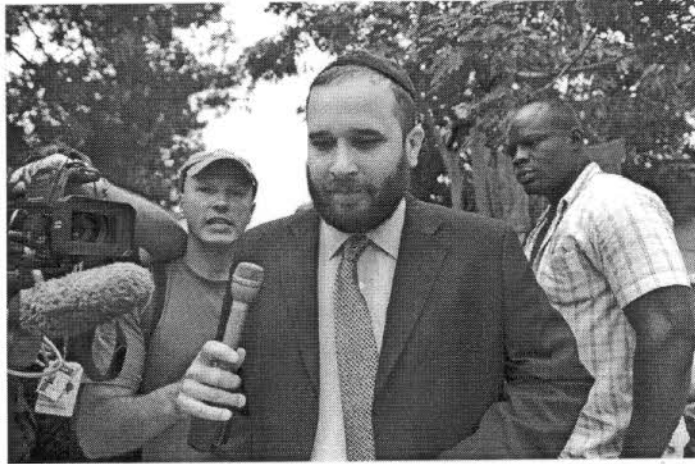

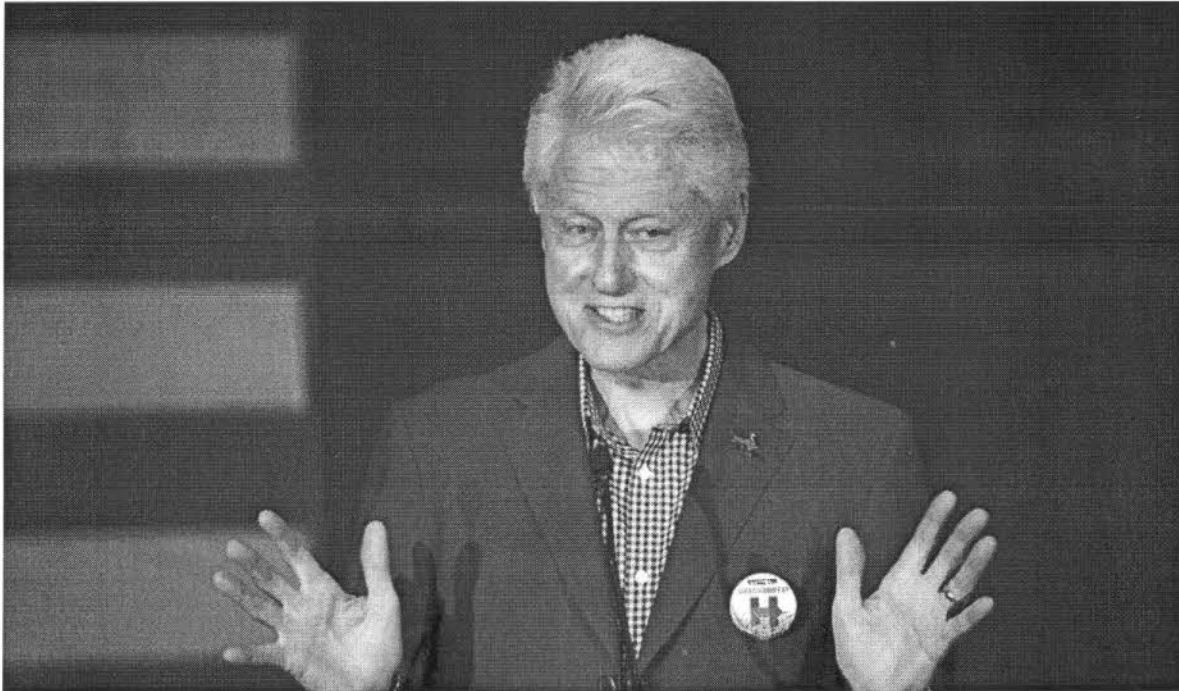

Bill Clinton ditched Secret Service on multiple 'Lolita Express' flights: Report

An investigation into official flight records of financier and convicted pedophile Jeffrey Epstein's "Lolita Express" are once again dragging former President Bill Clinton into the national spotlight.

Flight logs obtained by Gawker in January 2015 put Mr. Clinton on the billionaire's infamous jet more than a dozen times — sometimes with a woman whom federal prosecutors suspect of procuring underage sex victims for Mr. Epstein. Fox News reported Friday that records show Mr. Clinton declined Secret Service protection on at least five flights.

The network's investigation reveals Mr. Clinton flew on the Boeing 727 "Lolita Express" 26 times, more than doubling the previously reported 11 trips.

"Bill Clinton ... associated with a man like Jeffrey Epstein, who everyone in New York, certainly within his inner circles, knew was a pedophile. Why would a former president associate with a man like that?" said Conchita Sarnoff of the Washington, D.C.-based nonprofit Alliance to Rescue Victims of Trafficking, Fox reported. Ms. Sarnoff also authored a book on Mr. Epstein titled "TrafficKing."

Mr. Epstein was arrested in 2005 and signed a plea agreement in 2007 with the U.S. Attorney's Office, accepting a single charge of soliciting prostitution. He agreed to a 30-month sentence, registered as a "Tier 1" sex offender with the U.S. Virgin Islands and paid dozens of young girls under a federal statute providing for compensation to victims of child sexual abuse.

A Clinton spokesperson did not return the network's emails requesting comment. Martin Weinberg, Mr. Epstein's attorney, declined multiple inquiries into the flights.

Fox News said that the U.S. Secret Service declined to answer multiple Freedom of Information Act requests on the trips.

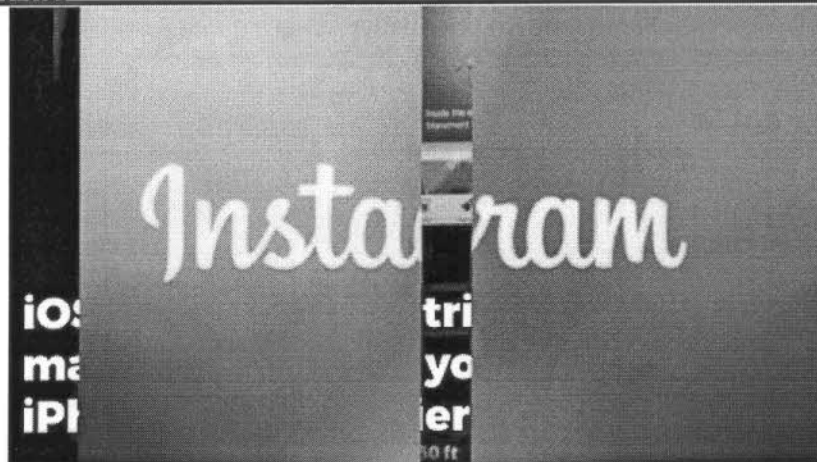

Attorneys for convicted sex offender Jeffrey Epstein touted his close friendship with Bill Clinton and even claimed the billionaire helped start Clinton's controversial family foundation in a 2007 letter aimed at boosting his image during plea negotiations, FoxNews.com has learned.

A FoxNews.com investigation in May showed the former president was a frequent flier on Epstein's infamous jet, dubbed the "Lolita Express," which earned its Nabakov-inspired nickname because it was reportedly outfitted with a bed where passengers had group sex with young girls.

Flight logs obtained exclusively by FoxNews.com show the former president taking at least 26 trips around the world aboard the "Lolita Express" -- even apparently ditching his Secret Service detail for at least five of the flights.

Epstein and his attorneys have said in multiple court filings that he has been the subject of the "most outlandish and offensive attacks, allegations, and plain inventions."

However, hundreds of pages of court records, including reports from law enforcement, reviewed by FoxNews.com, show Epstein was under close scrutiny by the Palm Beach police and FBI for more than a year.

The U.S. Attorney for the Southern District of Florida prepared charging documents that accused Epstein of child sex abuse, witness tampering and money laundering, but Epstein took a plea deal before an indictment could be handed up.

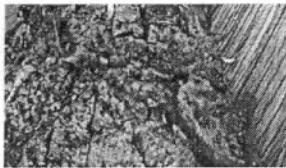
On Sept. 24, 2007, in a deal shrouded in secrecy that left alleged victims shocked at its leniency, Epstein agreed to a 30-month sentence, including 18 months of jail time and 12 months of house arrest and the agreement to pay dozens of young girls under a federal statute providing for compensation to victims of child sexual abuse. In exchange, the U.S. Attorney's Office promised not to pursue any federal charges against Epstein or his co-conspirators.

In a highly unusual civil lawsuit, Florida attorney Brad Edwards, and Paul Cassell, a former federal judge who represented some of Epstein's alleged victims, are suing the federal government over the secret non-prosecution agreement in hopes of having it overturned, so that Epstein could potentially face additional criminal charges.

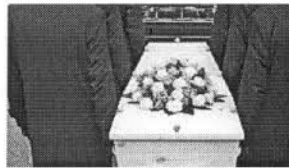

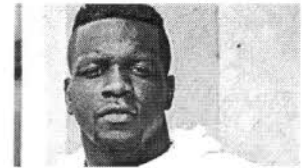

The 23-page letter, written by high-powered lawyers Alan Dershowitz and Gerald Lefcourt, was apparently part of an ultimately successful bid to negotiate a plea deal before Epstein could be tried for using underage girls in a sex ring based in Palm Beach, Fla., and his private island estate on the 72-acre Virgin Islands home dubbed "Orgy Island." Epstein spent 13 months in prison and home detention after agreeing to a plea deal in which he admitted to soliciting an underage girl for prostitution.

"Mr. Epstein was part of the original group that conceived the Clinton Global Initiative, which is described as a project 'bringing together a community of global leaders to devise and implement innovative solutions to some of the world's most pressing challenges,'" read the July 2007 letter to the U.S. Attorney's office in the Southern District of Florida. "Focuses of this initiative include poverty, climate change, global health, and religious and ethnic conflicts."

The hedge fund magnate's true role in creating the foundation could not be confirmed. Whether Epstein was an actual founder of the foundation or exaggerated his role in a phony effort to appear altruistic is not clear.

Mr. Epstein was part of the original group that conceived the Clinton Global Initiative, which is described as a project "bringing together a community of global leaders to devise and implement innovative solutions to some of the world's most pressing challenges." Focuses of this initiative include poverty, climate change, global health, and religious and ethnic conflicts.

Epstein is not cited in official paperwork filed by the Clinton Global Initiative as a founder or director. Neither The Clinton Foundation nor Dershowitz responded to

FoxNews.com's inquiry as to the extent of Epstein's involvement. FoxNews.com first reported that flight logs show the former president flew on Epstein's private plane dozens of times. But Clinton has publicly credited longtime assistant Doug Band, now counselor and director of the foundation, as conceiving of the idea.

The foundation has raised hundreds of millions of dollars, ostensibly for charitable works in places such as Haiti and Africa. But questions have arisen about how much of the donations actually went to aiding the poor, and critics have accused the Clintons of using it as a slush fund.

Attorneys describe the foundation, which has undergone name changes since its formation in 2005, as designed "to convene world leaders, forward-looking CEOs, and philanthropists to commit to take action on pressing global challenges."

In an effort to emphasize Epstein's close ties to Clinton before he was sentenced, his lawyers also credited Epstein with "hosting" a trip to Africa in 2002 on his private Boeing 727 for the Clinton Global Initiative, which Clinton himself attended, along with actor Kevin Spacey and comedian Chris Tucker, and other celebrities, purportedly for an anti-AIDS and economic-development mission.

"In a feature article about Mr. Epstein in New Yorker magazine, former President Clinton aptly described Mr. Epstein as a 'committed philanthropist with a keen sense of global markets and an in-depth knowledge of 21st century science,'" Epstein's lawyers wrote. "President Clinton reached this conclusion during a monthlong trip to Africa with Mr. Epstein, which Mr. Epstein hosted. The purpose of that trip was to increase AIDS awareness; to work toward a solution to the AIDS crisis; and to provide funding to reduce the costs of delivering medications to those inflicted with the disease."

Epstein also has supported the Clinton Foundation financially, but that was not made public until two years ago when a whistle-blower released the names of the super-rich, including Epstein, who held Swiss accounts at the HSBC bank.

The International Consortium of Investigative Journalists, which obtained the data from the whistle-blower, documented \$81 million being routed from HSBC Swiss accounts to The Clinton Foundation, including money from Epstein.

Epstein had various accounts totaling \$3.5 million, the investigative journalists group revealed and, in 2006, directed \$25,000 to The Clinton Foundation.

The close association between Epstein and Clinton is just one example of their personal and professional ties running much deeper than previously made

McFarlane also mounted a defence of Barclays' investment banking unit, under fire from investors for its sub-par returns.

McFarlane said some segments of the investment bank were very successful, adding that these were offset by weaker ones that are interdependent and necessary for the success of the others.

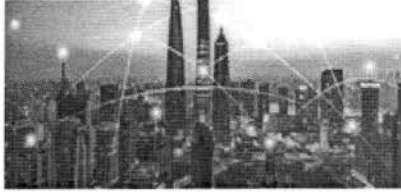
One shareholder drew the warmest applause of the meeting for asking whether the board and senior management should not have given up more of their own pay, as the bank cut its dividend to fund the revamp.

“Investing substantially in this company was one of the first things I did upon being appointed - and my interests are firmly aligned with yours,” he said.

Staley also said the bank was working hard to relieve the pressure on returns from fines for past conduct failings and was seeking to resolve outstanding issues as swiftly as possible.

“There will also be no let-up in the critically important work to transform Barclays’ culture,” he said.
