URGENT

Dear Mr Lefroy,

I had some bad news today – Judge McKenna of the Birmingham District Registry struck out a court order from Judge Worster: Forster ordered defendants to submit witness statements by the 21<sup>st</sup> of August. McKenna not only countermanded that – relieving defendants of the need to deny defrauding the courts - but he also struck out my entire court application.

I need two things from you: I would like to you contact McKenna directly.

i) I want you to tell him not only is his order absurd and corrupt, because it has been proven defendants obtained their verdicts fraudulently and 'fraud unravels all'.

ii) I also need you to tell him you know that defendants are in a position to have used blackmail to co-erce government and the judiciary to rig court orders.

We know that Jes Staley is CEO of Barclays, a defendant, and was an executive of JP Morgan at the time that my lawsuit was served. **Staley expressed intent to have the court application struck out in a letter to me.**

Now consider:

(I will not go over the evidence below, as its public domain, discoverable with any web browser, and I am pushed for time, but if there is any debate, get in touch and I'll send you the original source, or a revision).

- i) From my FOIA to Parliament and its reponse, it appears that Jes Staley won his appointment after lobbying from convicted child trafficker Jeffrey Epstein.
- ii) There appears to be a conspiracy between some MPs and Staley to deceive the Daily Mail and its readership that Staley's appointment would be scrutinized by Parliament...the Treasury...and this never happened.
- iii) ...If so, it means Staley was put into power by Epstein, Parliament knows that, and nobody will admit it.
- iv) Epstein appears to have had an executive role in the Robin Hood Foundation in the USA, which reports to be a charity for children. Needless to say a child trafficker does not get involved with such organizations for the good of children.
- v) Staley is noted on his Wiki entry for being an executive of the RHF.
- vi) The RHF pays Haitian immigrants legal fees to migrate to the USA – we can assume this creates abandoned children in Haiti.
- vii) The Clinton Foundation (Bill Clinton personally) has lobbied for clemency against child traffickers & kidnapers in Haiti.

- viii) The principle purpose of child trafficking is child prostitution.
- ix) Barclays, under Staley, funds both the Clinton Foundation and the Clinton Global Initiative. This was **after** the Clinton-Haitian scandal came to light.
- x) Clinton was known to use Epstein's jet – 'Lolitta Express' numerous times.
- xi) Put all those together and you can figure that Epstein is running a paedophile ring, that Clinton and Staley are involved, and the names in Epstein's Black Book are compromised - they include the Rothschilds, Saudi Princes, the Royal Family, David Cameron and Tony Blair. That is not to say anyone on the list is a paedophile, but anyone on the list presumably has received phone calls from Epstein, was in semi-regular or regular communication, and subject to lobbying or blackmail.
- xii) My friend Katherine Frisk disappeared off the radar two days after exposing of all of this on The International Reporter, then turned up dead on the 30<sup>th</sup>. I believe you have seen the materials that warrant an investigation.
- xiii) When half the executive of Barclays get arrested for the Qatar Share buying fraud, Staley, CEO, gets away scoti-free.
- xiv) When he is found guilty of telling his security officers to prevent whistle-blowers exposing frauds to his own board, he gets away scot-free.

You need to tell McKenna his decision is patently corrupt. He was incriminated in previous correspondence, having refused to consider a court application on the basis I addressed him as Judge McKenna rather 'The Designated Mercantile Judge.' – anal evasiveness. The man is bent. It is not the first time he has been accused of discriminating against Litigants in Person.

The court is obstructing due compensation for frauds from foreign banks to British investors, that will cost the country billions in lost income.

You should be demanding that Lord Burnett resign *before* he takes office in October. His two court orders in my case show he is not fit for office.

**You told me you were worried that the Attorney General would laugh at you.** He will not find it so funny when you point out that Parliamentarians let Staley take control of Barclays and knew that he got his appointment as a result of the lobbying from Epstein, the head of an international paedophile ring. The Treasury Committee - as well as lying to the Daily Mail - covered up the gold rigging frauds in which Barclays and JP Morgan are incriminated, alongside Deutsche Bank.

I am sorry to have exposed you to all of this, and I am sorry to pressurize you into acting, you are my last hope to resolving between a comfortable retirement and a miserable demise. I trust that you appreciate the urgency. I would like you to email McKenna and Worster via the courts before monday. I would like a CC on that mail. McKenna needs to recuse himself from all further court action in this matter, and Worster's original court order resume. **Defendants must - at the very least - testify on the allegations of having committed fraud and perjury to win their restraining order.**
